

# Contest Rules

## Courtside View for Two

---

### 1. Contest Organizer

The *Courtside View for Two* contest is held and organized by Beneva Inc. (“Beneva” or the “Organizer”).

### 2. Contest Period

The contest will be held in Quebec in two separate phases:

- Phase 1: on Beneva’s website (see section 4.1): from July 2, 2025, from 12:00 a.m. (ET) to July 11, 2025, at 11:59 p.m. (ET) (“Contest Period”).
- Phase 2: on Beneva’s Instagram page (see section 4.2): from July 7, 2025, from 12:00 a.m. (ET) to July 11, 2025, at 11:59 p.m. (ET) (“Contest Period”).

### 3. Eligibility Conditions

To be eligible for the contest, a person must:

- **Be a resident of the province of Quebec**
- **Be age 18 or over on or before July 14, 2025**

### 4. How do you enter?

Participation in this contest is free, with no purchase necessary.

To enter the contest, participants must satisfy the eligibility conditions and the other conditions set out in these contest rules.

Subject to the limitations contained herein, there are 2 ways to enter during the Contest Period:

#### 4.1 Online

You must fill out an electronic entry form on the Beneva’s website.

## 4.2 Through Instagram

To enter, the person must:

- Follow Beneva's Instagram page: <https://www.instagram.com/beneva.ca/>
- Like the post promoting the contest
- Tag in the comments the people they would like to share this unforgettable experience with (note: tagging more than one person does not increase the chances of winning.)
- Indicate whether they prefer to win tickets for the daytime session (12:30 p.m.) or the evening session (7:00 p.m.)

**Limit: One entry per person**

## 5. Prize details

Entering this contest gives the participant a chance to win one of the following prizes.

### 5.1 On Beneva's website

The approximate total value of this prize (a pair of tickets) is \$600.

### 5.2 Through Instagram

Contest on Beneva's Instagram page: 2 winners will each receive 10 tickets for the Beneva Balcony at the National Bank Open presented by Rogers on July 31, for matches taking place in Montreal at 12:30 p.m. and 7:00 p.m., respectively.

Winners must be available on July 31 for the 12:30 p.m. and 7:00 p.m. sessions, respectively. Each winner

will receive 10 tickets: one for themselves and nine for guests of their choice. The approximate total value of this prize is \$3,000 per match.

## **6. Specific prize conditions**

The prizes cannot be redeemed for cash, transferred, assigned or exchanged.

Beneva reserves the right to assign the session (day and time) of its choice to the winner based on availability at the time of prize allocation and does not guarantee the winner's preferred session.

Beneva is not responsible if a session is canceled or rescheduled by Tennis Canada. The session will not be rescheduled or replaced.

## **7. Draw**

### **7.1 Date and location**

The prize will be awarded by a random draw from the eligible entries. The draw will be held on (for both the contest on Beneva's website and the contest on Beneva's Instagram page) will take place on July 14, 2025, at 1:00 p.m. (ET), in the presence of an employee witness at the Beneva office located at 2525, boul. ### **7.2 Odds of winning**

The odds of winning depend on the number of eligible entries received during the Contest Period.

### **7.3 Disqualification or cancellation**

Beneva reserves the right to disqualify persons or cancel entries that are not in compliance with these contest rules.

## **8. Participation limitations and exclusions**

### **8.1 Number of entries**

The number of participations per person is limited in accordance with the provisions under section 4 of these contest rules.

### **8.2 Participant exclusion**

Employees, mandataries, officers, administrators and representatives of Beneva Inc. and its affiliated companies, and individuals residing at the same address, may not enter the contest.

Also excluded from entering the contest are representatives, agents, firms and agencies attached or affiliated with Beneva Inc. and its affiliated companies as well as their employees and the persons with whom they are domiciled.

## **9. General conditions**

To be declared a winner, the entrants must be randomly selected and meet the following conditions:

- Confirm that they meet the eligibility conditions and other requirements of these contest rules.
- Correctly answer, without assistance and within a limited time, a mathematical skill-testing question.

Through Instagram

Be tagged by the Organizer under the contest post on Beneva's Instagram page to be informed of the prize claim process within 3 business days following the draw. Selected participants will be contacted up to a maximum of 3 attempts and will have 3 business days to respond to the Organizer via private message or under the Instagram contest post following the message left, if applicable. Failing to do so will result in forfeiture of the prize.

- Confirm that they meet the eligibility conditions and other requirements of these contest rules.
- Correctly answer, without assistance and within a limited time, a mathematical skill-testing question.

The Organizer reserves the right to disqualify any person or cancel one or more entries from a person who enters this contest or tries to do so by any means contrary to these contest rules or which would be unfair to the other entrants. The schedule of the National Bank Open sessions cannot be changed and is subject to the schedule planned by Tennis Canada.

The prize winner releases the Organizer, its advertising and promotional agencies and their employees, agents and representatives from any potential damage, harm or loss resulting from their acceptance or use of the prize.

#### **9.5 Limitation of liability – Contest operation**
