

CONTEST RULES

Courtside View for Two Contest

1. CONTEST ORGANIZER

The *Courtside View for Two* contest is organized by Beneva Inc. (“Beneva” or the “Contest Organizer”)

2. CONTEST PERIOD

The contest will be held in Quebec in two separate phases:

- Phase 1 on the Beneva website (see section 4.1): from 12:00 a.m. ET on July 3, 2024, to 11:59 p.m. ET on July 23, 2024 (“Contest Period”).
- Phase 2 on Instagram (see section 4.2): 12:00 a.m. ET on July 15, 2024, to 11:59 p.m. ET on July 18, 2024 (“Contest Period”).

3. ELIGIBILITY CONDITIONS

To enter this contest, participants must:

- Be a resident of the province of Quebec.
- Be age 18 or over on July 24, 2024

4. HOW TO ENTER

Participation in this contest is free, with no purchase necessary.

To enter the contest, individuals must satisfy the eligibility conditions and the other conditions set out in these contest rules.

Subject to the limitations contained herein, there are two (2) ways to enter during the Contest Period:

4.1 Phase 1

Online

By completing an electronic entry form on the Beneva website.

4.2 Phase 2

Online

To enter, the person must:

- Follow Beneva’s Instagram account (<https://www.instagram.com/beneva.ca/>)
- Like the post promoting the contest
- Identify in the comments the people they would like to share this unforgettable experience with. The number of people listed does not increase the chances of winning.

Limit: One (1) entry per person.

5. PRIZE DETAILS

Entering this contest gives you the chance to win one of the following prizes:

6. SPECIFIC PRIZE CONDITIONS

The prize cannot be redeemed for cash, transferred, assigned or exchanged.

Beneva reserves the right to assign the session of its choice (day and time) to the winner based on availability at the time the prize is awarded and does not guarantee the winner the session of his or her choosing.

Beneva is not responsible if a match is cancelled or postponed by Tennis Canada. The match cannot be attended at a later date.

7. DRAW

7.1 The prize will be awarded by a random draw from the eligible entries per phase.

7.3 Beneva reserves the right to disqualify persons or cancel entries that are not in compliance with contest rules.

8. PARTICIPATION LIMITATIONS AND EXCLUSIONS

8.1 The number of entries per person is limited, as described in section 4 of these contest rules.

8.2 Employees, mandataries, directors, administrators and representatives of Beneva Inc. and its affiliated companies, and individuals residing at the same address, may not enter the contest.

8.3 Also excluded from entering contests are representatives, agents, firms and agencies attached to or affiliated with Beneva Inc. and its affiliated companies, and their employees and all other individuals living with them.

9. GENERAL CONDITIONS

9.1 To be declared a winner, the entrant selected at random must:
